# 6.1 Pirate Pride - Andrea Schmidt and Students (PCHS) Butterfly Waystation

Dr. Devin Doll, Executive Director of Facilities and Operations, introduced Andrea Schmidt, PCHS science instructor, and the PCHS Science Club to the Board of Education. This spring, PCHS Science Club unveiled the Platte County School District Butterfly Waystation. This project started 3 years ago by Mrs. Redinger, last year's Teacher of the Year, and her Dual

Environmental class Mrs. Redinger passed the project on to Mrs. Schmidt when her family moved to Springfield last year. This project involved many different organizations and clubs to bring it to the beauty that you see today. Thanks go to incoming PCHS Freshman Parker

Messenger and Boy Scout Troop 351, PCHS Science Club members, and PCR-3 maintenance staff who have contributed to the design and installation of this 550 square foot butterfly waystation. Next steps include planting additional trees, adding mulch and benches, and installing a posted sign with a QR code leading visitors to related educational documents. PCHS AP Environmental students and PCHS Engineering students will be working on the educational documents and constructing the signage. Butterfly Waystations are places that provide resources necessary for monarchs to produce successive generations and sustain their migration. The waystation will be used by a variety of classes to learn about the migration, life cycle, and habitat of many plants and species native to our region.
