Each Bid shall be accompanied by a certified check, cashier's check, draft or letter of credit certified or issued by a state or national bank in the amount of at least five percent (5%) of the total amount of the Bid payable to Platte County R-3 School District, or in lieu thereof, the Bidder may furnish a Bid Bond in an amount of not less than five percent (5%) of the amount of the Bid. Such bond shall be issued by a surety authorized to do business in the State of Missouri, and made payable to Platte County R-3 School District, as a guarantee that such Bidder will enter into a Contract with the Owner for the Work described in the Bid and furnish bond as specified.
