

# **Memorandum of Understanding**

This Memorandum of Understanding (MOU) establishes a collaborative partnership between Platte County R-3 School District (School District) and the Northland Center for Advanced Professional Studies (CAPS) Board of Directors.

## **I. MISSION**

Northland CAPS is a program developed to serve the educational interests of students in Northland School Districts by developing partnerships between businesses/industries in our region and our Northland School Districts. These partnerships are being created in order to expand opportunities for students in the region to experience curriculum that is designed around business and industry standards and learning environments that are project based.

## **II. PURPOSE AND SCOPE**

The purpose of the MOU is to declare Platte County R-3 (School District) commitment to join the Northland CAPS partnership. Partners who approve the MOU are agreeing to support the development of programs and help identify and enroll student in the Northland CAPS program. Programs will be designed, implemented, and monitored by the Northland CAPS Board of Directors under the by-laws (see attached).

## **III. RESPONSIBILITIES**

Each member district superintendent or designee will annually work to help identify qualified board members to serve on the Northland CAPS Board of Directors.

Each member will also appoint a district designee to be the primary point of contact between the Northland CAPS Executive Director and the district high schools.

Partnering school districts also agree to pay all necessary tuition that is outlined in the organizational by-laws and fill the annual allocation of seats.

## **IV. TERMS OF UNDERSTANDING**

The term of this MOU is for a period from March 2025 through March 2028 beginning immediately upon approval and execution of the document. The agreement may be extended upon written mutual agreement of both parties. The agreements shall be reviewed annually to ensure it is fulfilling its purpose and make any necessary revisions.

Either organization may terminate this MOU upon thirty (30) days written notice without penalties or liabilities.
