

## 2024-25 Inclement Weather Plan

As we know, winter weather can cause disruptions to our District's academic calendar and student learning. The state of Missouri now has options for how school districts can address inclement weather days. Missouri districts can use traditional snow days or Alternative Methods of Instruction (AMI Days); thus we have options if in-school days are missed due to inclement weather. To ensure the most effective and efficient use of our academic calendar we have developed the following inclement weather plan to guide our decision making for the 2024-25 school year.

PCR-3 will observe traditional inclement weather days, resulting in no school and no virtual learning, for the first three days. Starting from inclement weather day four through day eight, the District will transition to Alternative Methods of Instruction (AMI) days, involving virtual learning. In the event that the District experiences more than eight inclement weather days, the Board of Education will assess the feasibility of waiving additional days while ensuring compliance with all state and federal requirements. Refer to the questions and answers below for further information and details regarding this plan.

\*\*Note: As the academic calendar does not incorporate weather make-up days, this plan proposes that the Board of Education consider waiving the first three inclement weather days. If all three days were waived our elementary schools would be 46.2 hours over the state required minimum number of hours. Secondary schools would be 79.6 hours over the state required minimum number of hours.

## Why has Platte County School District decided to develop an Inclement Weather Virtual Learning Day plan?

With an abundant amount of days lost to inclement weather in recent years, and because PCR-3 is a one-to-one district (where all of our students have devices), it was determined in Spring 2020, to explore this option. An AMI application was submitted by District leaders and approved by the Missouri Department of Elementary and Secondary Education. Any Inclement Weather Virtual Learning Day would not need to be made up at the end of the school year. Feedback received in recent years from our families shows that they would prefer to have the regular school year not go into June. The inclement weather make-up plan helps us toward that preference.

## What if school is canceled for an extended period of time?

In the event that the PCR-3 is closed for an extended period of time (6 consecutive school days), we will put Inclement Weather Virtual Learning Days Extended or AMI X into effect. This is a long-range plan to allow for your student's continuous learning.

#### **How will families be notified?**

Families would receive an alert from the Director of Communications, via text and phone call as we have done in the past, and information would be posted on our District website, Facebook, Twitter, Instagram, the District Hotline (816-858-2752), and local media.

We will do our best to anticipate these inclement weather days in order to give advance notice to our families. In the event that the school closing notice is provided with little notice, we would like to make sure your student has the necessary technology tools available to engage in the learning.

#### How would an Inclement Weather Virtual Learning Day look for my child?

Educational opportunities will be provided by the classroom teacher. All students will receive their assignments through their teachers' Google Classrooms and/or Canvas. Student attendance will be verified by participation in class virtual meetings and/or work completion.

### What if my child has an IEP (Individualized Education Plan)?

Please refer to your child's IEP, Form G for specifics for your child's access to services during an AMI day. Your child's case manager can answer any questions.

## What are the expectations for teachers during AMI days?

#### - Elementary

- Teachers will take attendance (class meeting and/or work completed)
- No new learning
- Continued learning from previously introduced topics
- Teachers host (or join- admin assigned) a class meeting on Google Classroom
- Teachers should assign a practice assignment in both the ELA and Math learning platform
- Teachers should be available to students throughout the day
- If a teacher is unable to meet with their classes, due to an ALD, the teacher needs to communicate with students and families
- Teachers should follow up on the activities when students return to in-person learning

#### - Secondary

- No new learning
- Continued learning from previously introduced topics
- Teachers should post course work, projects, etc via Canvas
- Teachers should log on at the start of each class period
- Teachers should be available to students via email throughout the day
- Lessons can be subject-specific, or can focus on community building
- If a teacher is unable to meet with their classes, due to an ALD, the teacher needs to communicate with students and families

## What are the expectations for students during AMI days?

#### Elementary

- Students should check Google Classroom for announcements/updates from teachers
- Students should join Google Meets for their class meeting time
- Students should be dressed in appropriate clothing
- Students should ensure they have their device charged when they return to school
- Students should be prepared to share their learning from the AMI day

#### - Secondary

- Students should check Canvas/for announcements/updates from teachers
- Students should sign-on to Canvas to check for coursework
- Students should join Google Meets at the start of each class
- Student should be dressed in appropriate clothing
- Students should utilize their school-issued device for learning
- Student should ensure they have their device charged

## Below is the learning schedule for students on a virtual learning day:

Elementary students will engage in opportunities that extend their current learning. No new learning will be part of an AMI day. In addition to Reading and Math, choice boards will be provided for the 2024-25 school year in both Real World Learning and Specials. Students can pick one activity off of each choice board.

In some cases, students will log on to meet with their teachers during the correlating time slot on the schedule below. In other cases, students will not meet directly with teachers. However, all students will need to meet with their PLT teacher on an AMI day, as attendance will be taken for this period.
