Missouri General Assembly Legislative Update Cooperating School Districts of Greater Kansas City July 2, 2024

With the legislative session being concluded on May 17, legislative activity has now been taking part within the governor's office. The governor has until July 14 to sign or veto the few bills that actually made it to his desk during this past session. However, the governor had until June 30 to sign or line-item veto provisions of the fiscal year 2025 budget. The budget that the legislature sent to the governor was a little over \$51 billion. The governor line item vetoed approximately \$1 billion of that budget. Attached is the governor's letter regarding the reasoning for the vetoes in HB2002.

Some of the items relating to education that stayed in the budget are as follows:

- \$361.4 million to fully fund school transportation needs for the third year in a row.
- \$121 million to again fully fund the K-12 Foundation Formula for the sixth year in a row.
- \$<u>69.3</u> million for the Career Ladder program to reward educators who go above and beyond normal duties.
- \$33.4 million for the Teacher Baseline Salary Grant Program which increases baseline K-12 educator pay to \$40,000 per year (participating schools no longer have a grant match requirement).
- \$3.1 million for Missouri Youth Apprenticeships.
- \$56 million for public and charter schools to provide Pre-Kindergarten programs to all students qualifying for free and reduced lunch.
- \$54.8 million to increase rates for child care providers.

Below is a list of all the line-item vetoes for House Bill 2 and attached to this report is the letter from Governor Parson explaining the reasoning for each veto. The majority of the vetoes were due to the passage of SB727 and the ongoing costs associated with the provisions of the bill.

The Governor's reasoning for these vetoes is as follows:

TO THE SECRETARY OF STATE OF THE STATE OF MISSOURI 102nd GENERAL ASSEMBLY SECOND REGULAR SESSION

Herewith I return to you Senate Substitute for Senate Committee Substitute for House Committee Substitute for House Bill No. 2002 entitled:

AN ACT

To appropriate money for the expenses, grants, refunds, and distributions of the State Board of Education and the Department of Elementary and Secondary Education, and the several divisions and programs thereof, to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to transfer money among certain funds for the period beginning July 1, 2024, and ending June 30, 2025.

I hereby veto \$10,000,000 Department of Elementary and Secondary Education Federal Emergency Relief 2021 Fund for the Close the Gap Program. I hereby veto \$1,300,000 Budget Stabilization Fund for asthma and allergy treatment programs. The State funded this project last fiscal year with the intention that it was a one-time investment. Additionally, the General Assembly grossly overappropriated Budget Stabilization Funds.

To contract with a vendor to provide to public schools asthma rescue medication. From \$1,300,000 to \$0 from Budget Stabilization Fund. From \$2,300,000 to \$1,000,000 in total for the section.

On June 28, 2024 I approved said Senate Substitute for Senate Committee Substitute for House Committee Substitute for House Bill No. 2002, except for those items specifically vetoed and not approved.
